

4. Input Good Till Period (Good Till Period can be set for three trading days at maximum. If the order which is valid for more than one trading day is not fully executed, cancelled or rejected on a trading day during the Good Till Period, the outstanding part of the order will be automatically carried forward to next trading day until the end of the Good Till Period.)
5. Click “Continue”

If the order price is out of 24 spreads compared with the current price or the order includes odd lot:

6. A reminder message will be shown upon clicking “Continue”
7. Click the relevant check box for confirmation (not applicable to odd lot)
8. Click “Continue”

 3. Input Good Till Period. Good Till Period can be set for three trading days at maximum. (If the order which is valid for more than one trading day is not fully executed, cancelled or rejected on a trading day during the Good Till Period, the outstanding part of the order will be automatically carried forward to next trading day until the end of the Good Till Period. Once triggered, the order will lapse at the end of that trading day and will not be carried forward to next trading day regardless of whether the order is fully executed or not.)






